1. Drug problem in US – doubled in ten years
Reason: method to deal with it (punishment) does not work; education and treatment better
2. Call for decriminalisation and legalisation
For Against
<ul> <li>saves police time – focus on more serious crimes</li> <li>drug use and addiction will increase</li> <li>more drug-related crimes</li> </ul>
<ul> <li>more money for treatment and education</li> <li>harm to drug users and non-users</li> </ul>
<ul> <li>protects rights of drug users</li> <li>reduces temptation to commit crimes</li> </ul>

3. Root causes: racism, poverty, access to health care and housing
Better solution: create employment, narrow gap between rich and poor (in health and housing)

In the US, the number of drug users has doubled in ten years. It appears that punishing drug users has not worked. Many drug experts now believe that making drug use illegal only causes other social problems. Police corruption and other crime would increase. They argue that the money spent on fighting drugs would be better spent on fighting other crime and on prevention, including education and treatment. Drug use, they argue, is a question of individual rights. However, others argue that legalisation would actually increase crime and lead to increased drug use. Finally, others think that fighting the underlying factors of poverty and unemployment is a better long-term solution to the drug problem.

## **RELATE/REFLECT** Make connections with what you already know about the topic and how you will use this new information.

I understand the arguments for and against the legalisation of drugs and the need to seek better solutions and getting to the root causes that lead people to take drugs. This article would be useful for my essay on drug use in NZ. I will do more research into drug laws in NZ compared to the US and other countries. I will also need to find more information and statistics about the validity of the connection between poverty and other social issues and the increase in drug use.
